Your attention is adverted to **Press Notification/ Advertisement No. RW/01/2022 of 05 May, 2022** for Recruitment of Assistant Professors / Associate Professors / Professors on Vacant Regular Posts in Dr. Bhimrao Ambedkar University, Agra. (See Annexure 1)

The above cited Advertisement needs to be quashed ex facie and at first instance as it is ultra vires. The University is run by the Acts and Statutes and not by whims and fancies of the Officers of the University. Only a permanent Vice Chancellor is empowered to make permanent appointments. The Acting Vice Chancellor / कार्यवाहक कुलपति can only take day to day decisions. **Notification/ Advertisement No. RW/01/2022 of 05 May** is also thoroughly manipulated to favour a few persons in the close coterie of the present Acting Vice Chancellor / कार्यवाहक कुलपति Professor Vinay Pathak. The Roster System has been used, misused, abused and disused to prepare vacant positions that are highly skewed to favour the people of the coterie.

A keen perusal of the above cited advertisement will reveal the mala fide intentions and post facto manipulation by Professors of the coterie of the present Acting Vice Chancellor / कार्यवाहक कुलपति Professor Vinay Pathak who have prepared this to illegally favour their

kith and kin. All the posts in the Institute of Home Science, where these persons have their interests to serve, are unreserved. While all the posts in other Institutes are reserved for different categories. It is difficult to decipher whether the University as a Unit has been considered or Institute as a Unit to implement the Roster System. It appears to have been manipulated as per the need. We have been informed that one of the Professor's from this group has even got an EWS Certificate prepared for wife. This imbalance and manipulated use of the Roster System has rendered several deserving candidates ineligible to apply. The travesty of fact is that the Professors close to the Acting Vice Chancellor of the University are performing administrative functions instead of teaching and manipulating rules for their own benefit.

We demand that the ***Press Notification/ Advertisement No. RW/01/2022 of 05 May, 2022 be quashed instantaneously and without delay and Law of Natural Justice be upheld. The vacant regular posts may be re - advertised after the appointment of a permanent Vice Chancellor and also after judicious application of the Roster System.***

As a group of aware citizens and also alumni of this University, we are approaching you for justice. We are sanguine that you will do the needful at the earliest to resolve the issue cited above and avoid waste of valuable time of Honourable Courts. You will appreciate that Judicial recourse is costly and time taking and members of the public raising genuine issue must not be compelled to approach the Hon'ble Court for redress of administrative lacuna.


